ORDINANCE ESTABLISHING A COMMUNITY REINVESTMENT AGENCY FOR THE TOWN OF DUTCH JOHN

ORDINANCE NO. 2017-002

PREAMBLE:

WHEREAS, Dutch John anticipates the transfer of Federal Grant lands from Daggett County; and

WHEREAS, Dutch John anticipates the need to develop, sell, lease or otherwise add value to the Town to aid in the growth and financial wellbeing of the town, and

WHEREAS, Utah State Code section 17C – “Limited Purpose Local Government Entities – Community Reinvestment Agency Act” allows for the creation of a Community Reinvestment Agency (CRA) that has special abilities to facilitate the development of Town Owned Properties.

ORDINANCE:

THEREFORE, Be it ordained by the Town Council of the Town of Dutch John that the Dutch John Community Reinvestment Agency (CRA) be created as per the requirements of Utah State Code 17C

This ordinance shall be in full force and effect from May 8, 2017
