Resolution Tentatively Adopting the Tentative Budget, Establishing Date, Time and Place for Public Hearings and Ordering Publication of Notice as Required by Law

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF DUTCH JOHN (TOWN) ACKNOWLEDGING THE FILING OF THE TENTATIVE BUDGET FOR FISCAL YEAR 2025-2026 PREPARED BY THE TOWN MAYOR PURSUANT TO SECTION 10-5-107 OF THE UTAH CODE, TENTATIVELY ADOPTING THE TENTATIVE BUDGET, ESTABLISHING THE DATE, TIME AND PLACE FOR PUBLIC HEARINGS ON ADOPTION OF THE TENTATIVE BUDGET AS THE TENTATIVE FINAL BUDGET FOR FISCAL YEAR 2025-2026 AND ON ADOPTION OF A FINAL TAX LEVY FOR FISCAL YEAR 2025-2026 PURSUANT TO SECTION 59-2-919 (4) OF THE UTAH CODE AND ORDERING PUBLICATION OF NOTICES AS REQUIRED BY LAW.

WHEREAS, under section 10-5-107 of the <u>Utah Code</u>, the Mayor of the Town of Dutch John ("Town") shall, on or before the first regularly scheduled meeting of the Town Council in May, prepare for the ensuing year a tentative budget for each fund for which a budget is required, make the tentative budget available for public inspection and submit the tentative budget to the Town Council; and

WHEREAS, under section 10-5-107 of the <u>Utah Code</u>, on receipt of the tentative budget, the Town Council shall review, consider and tentatively adopt the tentative budget; and

WHEREAS, the Town Mayor prepared the Town tentative budget for fiscal year 2025-2026 as required by law and submitted the tentative budget to the Town Council on or before May 14, 2025, which is the first regularly scheduled meeting of the Town Council in May; and

WHEREAS, the Town Council wants to acknowledge receipt of the tentative budget for fiscal year 2025-2026 prepared by the Town Mayor; and

WHEREAS, the Town Council wants to review, consider and tentatively adopt the tentative budget prepared and submitted by the Town Mayor; and

WHEREAS, the Town Council wants to review and make any changes to the tentatively adopted tentative budget as the Town Council deems appropriate prior to adoption of the tentative final budget.

WHEREAS, the Town Council wants to establish the date, time and place of the public hearing on the tentative budget prior to adoption of the tentative final budget for fiscal year 2025-2026 as required by section 10-5-108 of the <u>Utah Code</u>; and

WHEREAS, since the Town Council is considering a property tax levy for fiscal year 2025-2026, the Town Council wants to establish the date, time and place of the public hearing on adoption of the final property tax levy pursuant to section 59-2-919 (4) of the <u>Utah Code</u>; and

WHEREAS, the Town Council wants to direct the Mayor and other Town officials to publish notice of the public hearing on the tentative budget prior to adoption of the tentative final budget as required under sections 10-5-108 and 63G-30-102 of the <u>Utah Code</u>; and

WHEREAS, the Town Council wants to direct the Mayor and other officials to publish notice of the public hearing on the adoption of a final property tax levy as required by sections 59-2-919(6), 45-1-101 and 63G-30-102 of the <u>Utah Code</u>.

NOW THEREFORE, be it resolved by the Town Council of the Town of Dutch John as follows:

- 1. The Town Council acknowledges receipt of the tentative budget for fiscal year 2025-2026 prepared by the Town Mayor.
- 2. The Town Council tentatively adopts the tentative budget for fiscal year 2025-2026, as prepared and submitted by the Town Mayor.
- 3. The tentative budget for fiscal year 2025-2026 shall be available for inspection on the Town website and at the Dutch John Community Center, 530 South Boulevard, Dutch John, Utah until June 11, 2025.
- 4. The Town Council shall review the tentatively adopted tentative budget and make changes as the Town Council deems appropriate prior to adoption of the tentative final budget.
- 5. The Town Council shall hold a public hearing on the tentatively adopted tentative budget with any revisions the Town Council has made prior to adoption of the tentative final budget pursuant to section 10-5-108 of the <u>Utah Code</u> on June 11, 2025, beginning at 7:00 p.m. at the Dutch John Community Center, 530 South Boulevard, Dutch John, Utah.
- 6. The Town Council shall hold a public hearing on the proposed property tax levy prior to adoption of the final property tax levy for fiscal year 2025-2026 pursuant to section 59-2-919 (4) of the <u>Utah Code</u> on August 13, 2025, beginning at 6:00 p.m. at the Dutch John Community Center, 530 South Boulevard, Dutch John, Utah. The Town Council understands that the County Auditor may need to resolve a conflict of overlapping public hearing dates and times under section 59-2-919 (8)(d) of the <u>Utah Code</u> and require a different date and time.

- 7. The Town Council directs the Mayor and other officials to publish notice of the public hearing on June 11, 2025, prior to the adoption of the tentative final budget as required under sections 10-5-108 and 63G-30-102 of the <u>Utah Code</u>; and
- 8. The Town Council directs the Mayor and other officials to publish notice of the public hearing on August 13, 2025, prior to the adoption of a final property tax levy as required by sections 59-2-919(6), 45-1-101 and 63G-30-102 of the <u>Utah Code</u>
